#### CANDIDATES FOR DEPUTY-PRESIDENTSHIP.

I would now request hon'ble members to hand over to me the nomination papers for the election of Deputy-President which has become necessary on account of my appointment as President. The hon'ble members who wish to propose and second a candidate should first ascertain from him that he is willing to act as Deputy-President if elected.

The nominations were then handed in to the President.

The first nomination is of Babu Mithila Sharan Sinha proposed by Babu Shiva Shankar Jha and seconded by Babu Baghubans Thakur. The second nomination is of Mr. Yunus proposed by Maulavi Hafiz Nurul Haqq and seconded by Maulavi Saiyid Mubarak Ali. The third nomination is of Babu Shyam Narayan Sinha Sharma proposed by Babu Maheshvar Prashad Narayan Sinha and seconded by Babu Ganesh Dattå Singh. The fourth nomination is of Rai Bahadur Prithi Chand Lal Chaudhuri proposed by Maharaj-Kumar Gopal Sharan Narayan Singh and seconded by Mr. Shah Muhammad Yahya.

These are the four nominations received for the office of Deputy-President. The election will be held to-morrow.

I take this opportunity for the benefit of those members who were not present at the last Council session to repeat what my worthy predecessor the Hon'ble Mr. Sinha has impressed upon the hon'ble members who thus stood as candidates for the office of Deputy-President. A moral obligation rests on the hon'ble member who will be elected to that office not to take part in controversial debates. It is based upon a sound principle that the Deputy-President may at any time be called upon to occupy the Chair and if he has expressed strong views on any particular subject the confidence of the Council in his impartiality may be impaired when he is subsequently called upon to preside during that debate or the discussion of any subject connected with it.

## HOUSE AND LIBRARY COMMITTEES.

I have to make two more announcements:-
